## Organization Description:

Since 1981, the Golden Gate National Parks Conservancy (Parks Conservancy) has served as the nonprofit partner of the National Park Service, collaborating with the Presidio Trust, partners, donors, and the community to support the Golden Gate National Recreation Area (GGNRA). The GGNRA stretches across three Bay Area counties north and south of the Golden Gate Bridge and includes iconic places such as Muir Woods National Monument, Fort Point National Historic Site, Alcatraz Island, Crissy Field, Mori Point, Lands End, and the Presidio of San Francisco.

The Parks Conservancy engages at the intersection of national park sites, local communities, social justice, and climate resilience. Collaborating with partners, our staff are dedicated to enhancing public awareness and providing volunteer and educational opportunities in the parks. We are park builders, caretakers, ambassadors and educators, all working to connect people to parks in support of our vision *Parks for All Forever*. Join us.

#### Branch/Unit Description:

This position works within the team of the Interpretation and Education rangers on Fort Point/Presidio. Our team consists of about 8 rangers of all different backgrounds, but all of whom are passionate about interpreting the history of the area. The team really focuses on supporting one another and helping each other grow.

#### **Position Overview:**

This position will support on developing a public program (with a focus on mental health) practicing public speaking skills, visitor interaction, and educating the public on park resources. The position will offer opportunities for the intern to learn about what park rangers do on Fort Point and Presidio as well as what opportunities are available as a potential career after education.

This position is located at East Beach, Fort Point, & Presidio of San Francisco. The start date for this position is June 3rd, 2025, with an end date of August 15th, 2025. Work is performed Fully in-person. The work schedule for this position is Tues- Sat or Sun-Thurs. 9am-5:30pm. Interns must be able to work in half-day or full day increments. Interns must have a Social Security Number or and Individual Taxpayer Identification Number to receive stipend. This position is only available to students currently enrolled at College of Marin, SF State University, and City College of San Francsico.

# Learning Objectives:

- Learn methods of Interpretation of natural and historic park resources
- Learn to conduct research on park topics like mental health
- Learn to create program outlines and how to present topics to the public
- Learn Audience Centered Experience to help enhance visitor education and engagement
- Learn how to apply and interview for Park Ranger Positions
- Network with park rangers and learn about career opportunities within the National Park Service
- Improve public speaking skills and general professional skills

#### Essential Functions and Responsibilities:

- Research and develop programming on mental health in the military
- Learn Park Service Site operations
- Research Fort Point and Presidio
- Develop programming with guidance of fellow park rangers
- Present public programming ranging from programs, tours, and pop-ups
- Walk around the site and initiate informal conversations with visitors making clear to visitors that the rover is available to answer questions, offer guidance, or otherwise serve core functions.

- Ability to interact with visitors from around the world and of diverse backgrounds

- Clear communication skills to adapt to changing scenarios at park sites
