

Park Steward Academic Intern

Golden Gate National Recreation Area; In Person Part-Time or Full-Time, Summer 2025 Available only to students currently enrolled at COM, CCSF, and SFSU

Organization Description:

Since 1981, the Golden Gate National Parks Conservancy (Parks Conservancy) has served as the nonprofit partner of the National Park Service, collaborating with the Presidio Trust, partners, donors, and the community to support the Golden Gate National Recreation Area (GGNRA). The GGNRA stretches across three Bay Area counties north and south of the Golden Gate Bridge and includes iconic places such as Muir Woods National Monument, Fort Point National Historic Site, Alcatraz Island, Crissy Field, Mori Point, Lands End, and the Presidio of San Francisco.

The Parks Conservancy engages at the intersection of national park sites, local communities, social justice, and climate resilience. Collaborating with partners, our staff are dedicated to enhancing public awareness and providing volunteer and educational opportunities in the parks. We are park builders, caretakers, ambassadors and educators, all working to connect people to parks in support of our vision *Parks for All Forever*. Join us.

Branch/Unit Description:

As NPS Zone Stewards we are responsible for the maintenance and upkeep of iconic Golden Gate National Recreation Area locations in San Francisco and San Mateo Counties. Each Steward collaborates with the community by hosting volunteer programing to accomplish our wide variety of duties. Work often includes landscaping, historic structure maintenance, developed recreation maintenance, basic natural resources tasks, signage and irrigation. Our main focus is to create safe and enjoyable opportunities for park visitors. From the hills below the Golden Gate Bridge down to Mori Point, it is up to us to provide an excellent park experience.

Position Overview:

The Park Steward Apprentice will assist in the set up and take down of volunteer events. As this internship progresses, the intern will have the opportunity to foster communication with volunteers, develop programming for events, and lead portions of volunteer projects. The intern will assist each Zone Steward's unique Thursday Drop In Volunteer events. Interns are expected to learn basic land management practices utilizing a variety of hand tools.

Interns will also acquire knowledge of printers, laminators, and various signage techniques. During the course of the internship, participants will play a role and creating mobile park signage that connects volunteers to programs, keeps visitors safe, directs visitors during special events, and protects our natural resources

This position is located at Crissy Field. The start date for this position is June 3rd, 2025, with an end date of August 15th, 2025. Work is performed Fully in-person. The work schedule for this position is Tuesday-Friday 7am – 3:30pm. Interns must be able to work in half-day or full day increments. Interns must have a Social Security Number or and Individual Taxpayer Identification Number to receive stipend. This position is only available to students currently enrolled at College of Marin, SF State University, and City College of San Francsico.

Essential Functions and Responsibilities:

- Safely utilize hand tools to accomplish outdoor tasks such as:
 - Basic landscaping (edging, seeding, pruning, weeding...etc)
 - o Invasive plant removal
 - Basic/reoccurring maintenance on equipment

- Assist in preparation and clean up of volunteer events
- Maintenance and organization of volunteer equipment
- Basic communication with volunteer groups
- Volunteer event program development
- Inventory temporary park signs
- Create, replace, and/or redirect mobile park signs
- Understand basic plant identification

Knowledge, Skills, and Abilities:

- Interest in local native plant identification
- Interest in learning basic landscaping skils
- Email communication skills
- Some experience managing a calendar
- Bilingual language abilities a plus
- Interest in growing group leadership skills

Health and Safety:

It is the goal of the Parks Conservancy to create and maintain a safe and healthy workplace. We work to mitigate hazards and risks that may cause harm to employees, consistent with state and federal laws.
